Catholic Presence in Our Homes

"The best and surest way to learn the love of Jesus is through the family," according to responsibility to keep a Catholic Presence in your homes, your Domestic Church.

Accordingly, here are some methods and traditions of keeping a Catholic presence in your own Domestic Church, your home: **The blessing of the home:** Invite a priest or a deacon to come to your place of dwelling and ask him to bless it. You can also ask to have an enthronement of your home to the Sacred Heart of Jesus and the immaculate Heart of Mary.

Devotions: Praying the Rosary routinely with the family. Wearing the brown scapular as a devotion.

Sacred images and sacramentals: Holy pictures and crucifixes should be hung throughout your house. Even a holy water font can be put in the house near the front door for personal blessings as a reminder of your baptism. Brothers, you can sprinkle holy water occasionally throughout your home. Parental blessings: Brothers, you can bless your children or grandchildren any time simply by tracing the Sign of the Cross on their foreheads.

Celebrate name days: Celebrate each other's patron saint's name on the day of the year that they are dedicated on.

A Prayer Corner: The Catechism teaches, "For personal prayer, use a 'Prayer Corner' with Sacred Scriptures and icons." You can place a small table in the dining room or living room or in a designated room and place on the wall

above the table an icon or a crucifix. You can place on this table holy water, prayer books, the Catechism, container of rosaries, and a Bible. A candle and flowers will also help give it more of a ceremonious flavor.

Put simply, "A family that prays together stays together" (Saint Mother Teresa). Also, the Catechism (#2694) tells us this, "The Christian family is the first place for education in prayer." My Brother Knights, you have to establish a pattern of prayer in your Domestic Church. Believe it or not, but this will be one of the most important things you can do as a Catholic grandparent, parent, uncle or aunt. Be an example of Prayer to your family!

We are very fortunate to have two of our seminarians being ordained to the priesthood next month. Deacons Jimmy Touzeau and Bruce Barnett will be ordained on June 7th at 6pm at the Cathedral in Charleston. I know that several of our councils have supported these men over the years and it would be great to have representative of those councils at the ordination. It has been several years since we have had three men ordained in one year. Thank you for your continued support of seminarians.

On May 4th, I had the honor of attending the solemn profession of Brothers Ronie Lorcha CRM and Rafael Padron CRM (home parish of Immaculate Conception in Goose Creek) of the Clerics Regular Minor (Adorno Fathers). At one point during the solemn profession, the two men laid prostrate on the floor and were covered with a funeral pall and a crucifix while the funeral tolls rang during the litany of supplication. This signified their death to self and their rising once again into new life, conformed into the life of Jesus Christ. It was a very powerful symbol and had a very powerful affect on not only the two men but on the congregation as well. The Adorno Fathers profess four vows: obedience, chastity, poverty, and humility.

On May 7th, Brother Rafael Padron CRM was ordained a deacon at St. Joseph's parish in Lodi, NJ. He will be assigned to Jesus, Our Risen Savior in Spartanburg for his pastoral year in June. We are very fortunate to have Deacon Padron return to the Diocese of Charleston to serve the faithful in South Carolina.

In 2005, Sir Knight Wayman J. Johnson, a Vietnam Veteran of Aiken, SC was visiting the Charlie Norwood Veterans Administration Medical Center (CNVAMC) in Augusta, GA, and was introduced to the Veterans Administration Volunteer Service (VAVS) Program. Mr. Johnson with a few brother Knights and his personal monies initiated the local Knight of Columbus VAVS Program support. While he was Faithful Navigator in 2006-2007, the Msgr. George Lewis Smith Assembly #1074 of Aiken, SC was recognized at the 2007 Supreme Convention as the 2006-2007 International "To Be A Patriot" Award winner. Mr. Johnson continues to lead the group. Monies are raised through an annual golf tourna-

ment and rummage sales. Over the past fourteen years, it is estimated that \$24,000 of goods have been donated through the leadership of Mr. Johnson. During this same time, Mr. Johnson has personally logged over 1500 volunteer man hours at the CNVAMC. This does not include procurement time, organizational time, nor his 1-1/2 hour round trip drive each visit.

This past year, Mr. Wayman Johnson led a group of brother Knights twice a month to visits the Charlie Norwood VA Medical Center. They brought baked goods, coffee, toiletries and magazines to over 300 veterans each visit. Having adopted Ward 2B CLC (hospice) they made Memorial Day, July 4th, Thanksgiving and Christmas holidays special. This included facility setup for lunch and helping wheelchair patients from their room. They cooked and served hotdogs on the hotdog machine the Assembly previously donated. This year, Mr. Johnson personally logged 150 volunteer man hours at the CNVAMC.

For those of us who have the honor to call Wayman Johnson a friend, none of this is a surprise. Wayman is a devout Catholic and a devoted husband and father. He is a communicant at St. Gerard Catholic Church in Aiken, SC and he loves the Knights of Columbus.

As the SC District Award recipient, Wayman Johnson's was nominated for the Knights of Columbus Supreme Council award, competing with the other 73 District winners. In February, the Supreme Council announced Lt. Co. Wayman J. Johnson as the Knights of Columbus VAVS Male Volunteer of the Year. In the letter it was noted, "In all he does, (Wayman) serves his fellow veterans with respect, dignity and compassion, connecting with the veterans on all levels.... He truly is the epitome of all that it means to 'Serve those who served."

Worthy Grand Knights, Faithful Navigators and Members of the State Council:

Councils and Assembly Meetings

The Grand Knight and Faithful Navigator must conduct their meetings in accordance with the Charter, Constitution and Laws of the Knights of Columbus, supplemented by your Councils or Assembly's by-laws and according to parliamentary procedure. The standard reference on the subject of procedure is Robert's Rules of Order. The order of business for conducting a Council or Assembly meeting is outlined in *The Method of Conducting Council Meetings* (#10318) and *The Method of Conducting Assembly Meetings* (#10325), both available from "knightsgear.com." Presiding officers should control all meetings so that they follow the set agenda by limiting any sidebar discussion.

When a member wishes to speak, he does so by rising from his seat, addressing the chair by saying "Worthy Grand Knight" or Worthy Faithful Navigator" and renders the salute. (Representing the tree of the Cross, the member makes a vertical motion, with his arm and vertically opened hand, from top to bottom). The presiding officer recognizes the speaker by announcing his name and rendering the salute in return. (Representing the arms of the Cross, the presiding officer makes a horizontal motion, with his arm and horizontally open hand, from left to right).

The presiding officer should at all times refer to and address the offices by their proper title. He is thus setting a good example for all members to follow. All members who are not officers should be recognized by name as "Brother _____" or "Sir
