Remember that we are trying to increase our charitable giving in South Carolina. To do this we need more Knights, simple math tells us the more members we have the more we can do. A great gift for Christmas is a Knights of Columbus Membership. Please spread the word at church and in your parish that a Membership in the Knights is a gift that keeps on giving to help those in need.

Many of the Star Awards from last year have been given out over the past few weeks and more are planned in the next several weeks.

Thanksgiving went great across the state, many councils took the time to feed the poor of their community. One council that really stood out was council 3067 of Georgetown. Their numbers in feeding the poor has been growing and this year reach and all time high of 697 meals to the homebound and the needy. Volunteers came from everywhere to help with the 20 plus year event.

Our message from Carl Anderson was a bit different at our meeting in San Antonio, Texas, in mid-November. All councils now are being encouraged to become parish based councils. Home corporations will soon be a thing of the past. Home Corporations for a long time have become a drain on the councils and have diverted funds and council energy in the wrong direction. Each Home Corporation will now be required to sign a contractual agreement and the deadline will be April 2016. All Councils having a Home Corporation are asked to come to the Grand Knights Workshop January 16 along with the president of the Home Corporation to resolve these issues.

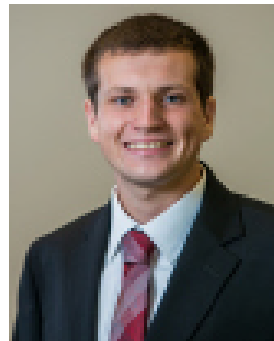
## From the Vocations Director

Larry Papineau has had to step down from being the vocation director due to illness at the state level and I have agreed to take over for him. Please keep Larry in your prayers.

The journey to the priesthood is a long one. It takes a diocesan priest from 7 to 9 years and a young man in a religious order 9 to 11 years to complete this journey. Statistic shows us that of 11 men that start the journey, 6 will be ordained. We presently have 9 young men in formation. Our next seminarian scheduled to be ordained will be Andrew Fryml from Jesus Our Risen Savior parish in Spartanburg in 2017.

We are fortunate to have two young men in their first year of college at Holy Trinity Seminary in Irving, Texas. Both are starting the discernment path to the priesthood which will take



nine years to complete.

Matthew Curley was home-schooled and from St. Catherine of Siena Church in Lancaster.

He is the

fourth of seven children and was raised on the family farm in Methune. Growing up on a farm and working closely with animals and the land helped to bring him closer to God and taught him the value of hard work and throwing himself into a task. His parents stressed the importance of his faith and encouraged his spiritual growth and development. He grew to love the idea of becoming a priest at a young age. His discernment deepened after going on a mission trip to Jamaica and by attending a discernment retreat in the eleventh grade. Matthew Bauer graduated from St. Joseph’s Catholic School in Greenville and is from Prince of Peace in Taylors. Matthew and his mother and stepfather moved to the upstate when he was in tenth grade. He had first thought of becoming a priest in grade school. All through school he was influenced by teachers who had encouraged him to pursue a vocation to the priesthood. Through spiritual guidance with Father Jeremi Wodecki, he realized that he wanted to become a priest.

Each year, in the diocese, we need to replace an average of 6 priests that we lose through retirement or death. Today, one third of the priests were ordained in the diocese, one third are on loan from other dioceses and one third are order priests. With the low numbers entering the priesthood, Bishop Guglielmone has had to work hard to attract priests to the Diocese of Charleston. We need to help him by keeping vocations in our prayers and to reach out and encourage young men who may have a vocation to say yes to God.

# From the State Ceremonials/ Protocol Chairman

Worthy Grand Knights and Members of the State Council: We have some districts working very hard on holding 1<sup>st</sup> Degrees and we have some that need to improve with one district that has not held a degree this fraternal year. Remember 1<sup>st</sup> Degrees are the life blood of a Council and the more held the more you have to do the work in the programs you are scheduling in your area. If you host a degree your District Deputy must be notified, as soon as it is scheduled, so he can make arrangements to attend or have someone represent him for that degree.

If a Council has not held a 1<sup>st</sup> Degree in the last 4 months then a practice must be scheduled to keep the team current and certified. This practice can be done on a meeting night or a weekend, in either case the District Deputy must be notified and present during the practice. The best way is to schedule and hold a degree with candidates at least once a quarter. Remember the preferred way for a degree is memorization with reading from the degree book as a second choice if a member is not available for a part on the degree team.

For the remainder of this Fraternal Year I ask all councils to forward to my attention a Form 450C for any degree held at their Council. I will use these to give credit to them because of a District Deputy shortage in some districts. This is only a temporary stop gap measure to prevent a false report in the State Newsletter.

For those that are trying to submit a Form 450 or a Form 450C to Supreme Council you can use the following email address until the form site is fixed. [ceremonials@kofc.org](mailto:ceremonials@kofc.org).

your District Deputy if he has submitted his Form 450 to the State Ceremonial Chairman. Until he submits his form to the Ceremonial Chairman the chart will not reflect a degree held.

**Protocol Input**

Worthy Grand Knights and State Council Members,  
CORRESPONDENCE

There are several types of correspondence today; letters, memorandums, e-mails and bulletins or newsletters.

Letters should be typed, when possible, on letterhead stationery. Official correspondence should include the council name, address, with the proper zip or postal code. The council name, number and location and telephone number should be shown in the heading.

If the writer of the letter wishes to present several different subjects, he should deal with them in a general manner in a covering letter and provide full details on separate enclosures. The council’s full name and address as well as that of the correspondent should appear on each enclosure. This procedure permits the recipient of the letter to forward the enclosures to the different departments or individuals who handle details of the topics under discussion.

Memos should be typed whenever possible. If hand-written, care should be taken that they are legible to the reader. A memo should deal with only one subject. It should be short, specific and informal.

E-mails need to be handled with care. Officers need to make certain that their e-mails are appropriate along with the content contained within the e-mail. Sending an e-mail does not ensure delivery to the intended recipient. E-mail is cost effective and can be an easy way for councils or assemblies to communicate, but it is not a guarantee of participation at an event. E-mails, as with letters, need to be clearly stated and have the main points separated. Make certain that e-mails that contain confidential information are not broadcast to a large group. E-mails, though cost effective, cannot replace the personal contact of a phone call or personal conversation.

Modern means of social communications provide members of the Knights of Columbus with powerful tools that can build up the Order by promoting its charitable mission and by encouraging members to live out their Catholic faith. The term “social communications” refers to, among other things, the internet, the World Wide Web, and social media. The term “social media” includes blogs and microblogs, social networking sites, and picture and video sharing sites, such as Twitter, Facebook, LinkedIn, Flickr, and YouTube.
