My Brother Knights and Family,

On October 13, 2018, the SC Catholics in Action Conference will be held in Columbia, SC. The conference will be held at Cardinal Newman School, 2945 Alpine Rd., Columbia, SC, from 10 a.m. to 6 p.m. Bishop Robert Guglielmone will be celebrating the Closing Mass, Bishop Nelson Perez, of the Diocese of Cleveland, will be giving the afternoon Keynote Address, and Gloria Purvis, from EWTN, will be giving the morning Keynote Address. The cost of the conference is \$25.00 per person and will include lunch. Further information can be found on the Diocese of Charleston website. I urge all members of the K of C and their wives to attend this worthwhile conference.

During our attendance at the Supreme Convention, your State Officers met to review and discuss various issues that we feel are our responsibility to make every effort to address and correct.

One of the daunting issues that we have addressed thus far, concerns a more efficient way of handling our convention planning year to year and a new approach to state membership. Rising hotel room rates, increasing food expense requiring large spending minimums, dwindling attendance by Council members and their Grand Knights has caused the State Council to incur large financial losses.

Every two years as State Officers progress from position to position, and just like State Officers go through a learning curve for their new position, a similar learning curve is required for organizing and execution of the State Convention. In order to eliminate this issue, the State Council has established the position of Convention Director. This person will report to the State Deputy, and he will continue until relieved from that position. He will be responsible for the running of the State Convention, and he will be able to negotiate contracts for future years, and he will submit the contracts to the State Council for their review and approval. The State Secretary will continue to be responsible for registrations, collection of convention fees, the establishment of the convention delegate

From the Vocations Director

Hello, my name is Deacon Jimmy Touzeau and I am a seminarian for the Diocese of Charleston. I am now entering my last year of formation and, God willing, will be ordained to the priesthood in June of 2019. I am a cradle Catholic and was born and raised in Pickens, South Carolina. I graduated from Clemson University with a degree in Financial Management. I worked at a lumber mill in West Union, South Carolina for about 15 years. After this I took a job in my home parish as an assistant to the pastor and a youth minister. After a year I took a job as Dean of Student Life at St. Joseph's Catholic School in Greenville, South Carolina. It was during my time working in the parish and at St. Joseph's that I heard and responded to the call of God. I believe that the Knights of Columbus also played a role in my discernment process. I was very involved with the Knights and enjoyed all the many activities that we did for our parish and community. I am a past Grand Knight and a past Faithful Navigator so I know first hand how much the Knights do and the tremendous amount of charity work that they do. I have also received much support and prayers from the Knights since entering the Seminary and I want to sincerely thank all of you for that.

Seminarians attend classes and are formed to be priests during the academic year which lasts from mid-August until early May. Some may wonder then; what do seminarians do during the summer when they are out of the Seminary? This is a good question and I will explain what we do over the summer. When we finish the academic year in May we usually go back to our homes in South Carolina. We will usually get a week or so off during this time. This is also the time, from mid-May to early-June when ordinations are held for the transitional diaconate and priesthood. We also have a gathering of seminarians during this time for all of us to get together for fellowship and fun. We pray and attend Mass and normally have someone come in to give conferences about various things concerning us as seminarians preparing to be future priests for the Diocese of Charleston.

Our summer assignments begin in June and normally last until August. The Vocation Director places seminarians in a parish for the summer. Father works to find parishes where a pastor welcomes the presence of a seminarian to help guide and teach them for the summer. So, what does a seminarian do in the parish over the summer? There are a great number of things we do. I would say one of the main things we do is to get ourselves more acquainted with the Liturgy. We attend

From the State Protocol Chairman

Worthy Grand Knights, Faithful Navigators and Members of the State Council:

Rules for Displaying the Flag of the United States

- If the flag is displayed from a staff projecting from a building, the union should be at the peak, unless flown at half-mast. When flown from a halyard over a sidewalk from a building pole, the flag should be hoisted union first from the building.
- The National Flag should be placed in the center, and higher, when displayed with a group of state, local or organizational flags flown from staffs.
- If the flag is displayed flat on a speaker's platform, it should be placed behind and above the speaker with the union to the speaker's right.
- When the flag is displayed over the middle of the street, it should be suspended vertically with the union to the north in an east and west street or to the east in a north and south street.
- When displayed from a staff in a church or public auditorium, the flag should hold the position of superior prominence, in advance of the audience and in the position of honor at the priest's or speaker's right as he faces the audience. Any other flag so displayed should be placed on the left of the priest or speaker or to the right of the audience.
- When displaying the flag against the wall with another flag, the U.S. Flag will be on its right (the viewer's left) with its staff crossing over the staff of the other flag.
- During rendition of the national anthem when the flag is displayed, all present except those in uniform should stand at attention facing the flag with the right hand over the heart. Men not in uniform should remove their head-covering with their right hand and hold at the left shoulder, the hand being over the heart. Persons in uniform should render the military salute at the first note of the anthem and retain this position until the last note. When the flag is not displayed, those present should face toward the music and act in the same manner they would if the flag were displayed there.
- When flags of states, cities or localities, or pennants of societies are flown on the same halyard with the flag of the United States, the latter should always be at the peak. When flags are flown from adjacent staffs, the flag of the United States should be hoisted first

and lowered last. No such flag or pennant may be placed above the National Flag or to its right.

- When carried in procession with other flags, the National Flag should be on the marching right. If there is a line of other flags, it should be center of the line. The U.S. Flag should always be staffed when carried on a float.
- When the flag covers a casket, the union should be at the head over the left shoulder. During burial, the flag must not touch the ground nor be lowered into the grave. To fly at half-staff, the flag should be hoisted to the peak, and then lowered. The opposite applies when lowering the flag from half-staff.
- When the flag is passing in parade, being hoisted or lowered, all present should face it, stand at attention and salute; uniformed persons render the military salute; women and uncovered men place their right hand over their hearts. Men should remove their hats, holding them over their hearts with their right hands.
- No flag or pennant will be flown above or to the right of the U.S. Flag at the same level, except the church pennant. This pennant may be flown above the flag during religious services at sea.
- When flags of two or more nations are displayed, they should be the same size and flown from separate staffs. Customs forbids the flag of one nation to fly over another in peacetime.
- Although the flag should be a distinctive feature at an unveiling of a statue or monument, it should never be used as the covering or veil.

Florence Council Announces Ultrasound Initiative

The Msgr. Charles D. Wood, Council 5194, located in Florence, SC, is proud to announce an Ultrasound Initiative for A Choice 2 M8K Crisis Pregnancy Center located in Florence, SC.

A Choice 2 M8K Crisis Pregnancy Center was established in 2009 to provide a safe haven for women who are experiencing an unplanned and unwanted pregnancy. The Center is based on the belief that life begins at conception and is a gift from God, who makes no mistakes. The Center exists to help others make the right choice. Rising from the tremendous need for a ministry dedicated to helping women in crisis, A Choice 2 M8K is the only independent crisis pregnancy care center in Florence and the surrounding area. The Pregnancy Center has passed the scrutiny of the Catholic Diocese of Charleston and the Knight’s Supreme Headquarters to insure they are doing everything possible to assist Florence area pregnancies to a natural conclusion.

While the Knights have installed 16 ultrasound units throughout South Carolina, none are located close to the Florence area. The quoted ultrasound unit is priced at \$32,000. So Council 5194 must raise \$16,000 and then apply to have Supreme fund the balance for the machine.

Studies show that each ultrasound machine saves 4 babies per week from abortion and that between 85 to 90% of the parents that see their baby with an ultrasound choose life.

Council 5194 is working on their half of the initiative, do you think your Council can help out to help make the dream a reality even sooner?

preliminary list and the final delegate roll call listing.

I have discussed this position with the individual who I feel meets the requirements. Therefore, I have appointed Ron Stanley, our current Membership Director, to this position effective on Sunday, September 9, 2018. Ron is doing a tremendous job as Membership Director, however, the State Council feels that we have a responsibility to the membership to bring the Convention's financial loss under control. Ron served 2 years as Grand Knight and District Deputy for 4 years. Ron was convention chairman of the 2006 State Convention held in Greenville and the 2008 State Convention held in Spartanburg. His approach to details and organization of the convention resulted in a profit to the State Council and Councils that provided seed money to the convention. Ron has been Director of SpartOberfest, Spartanburg's Oktoberfest which celebrates its 4th year next week.

I contacted Bob Rooney to discuss the position of Membership Director to replace Ron Stanley. Bob has been a member of the Knighthood Degree team and has traveled the state in conducting the Knighthood Degree as CO and PFC. Before his retirement, Bob was a Marketing Director, and his people skills are outstanding. At the completion of the last Knighthood Degree, I had all of the State Officers in attendance speak with Bob regarding his interest in the position and his vision regarding membership and his approach and methods that need to be taken to increase membership. After talking with Bob, all State Council Officers agreed with my assessment, and I have appointed Bob to fill the position of Membership Director. Ron and Bob will be conferring on our current membership input, and I am sure that Ron will be available to Bob as a reference.

At last count, we have achieved over 14% of our input goal. Many of the Councils have contributed to this input, and I ask Councils that have not held an Admission Degree to make every effort to conduct one. Our online membership is moving along, and through the end of August we have added over 7 prospective members. Take some time and review your Supreme account, and under the category of Prospect tab you will be able to see all of the assignments that have been made. If your Council appears under the assigned list, take time and make contact with the member.

Finally, the bowling tournament scheduled for September, 29, 2018 is looking for members to compete. All of the profits incurred will go to the Coats for Kids program. Often during the last Fraternal Year, we were questioned as to when the State Council will be running a Bowling Tournament. We have listened to you, and we are attempting to make this an annual event. Lack of participation will force us to eliminate this event next year. Please call Jeff Crouch, our State Warden, and sign up. Information on the tournament can be found on

the State's website. The experience of brother Knights getting together is worth your attendance.

Some of these include: helping with vacation bible school, youth ministry, hospital and homebound ministry, adult faith formation, altar server training, just to name a few.

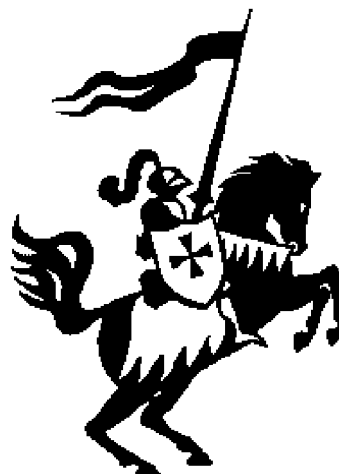
In a way it is like a co-op experience in college or on the job training. We live with and work alongside pastors. We learn what living in a rectory is like. We get to attend the various events with our pastor to try and see what it will be like. This includes attending dinner parties, going to the hospital to observe the anointing of the sick, visits to homebound parishioners, attending staff meetings, and whatever else that may happen in the life of a pastor.
